
Speedy JSC routing label specification

(v1.02)



The parcel label with its bar-coded information forms the logistical basis of the Speedy system. For all parties involved these specifications define the standard, which is essential to the production and use of the Speedy parcel label. The Speedy system can only be operated at a high-quality level if these specifications are complied with.

The Speedy routing label must have the format DIN EN ISO 216 A6 (equivalent to 105x148 mm) and includes the following sections:

1. Speedy barcode. The barcode format is Code 128 and contains the parcel number and routing information.



2. General shipment information - In the first section (on the left) is the Speedy logo, the sequential number of the parcel and the total number of parcels ("1/1 of") and the waybill number (51963801171), masked COD amount and declared value for the shipment. Next is the pick-up/drop-off date and time section and on the right - the calculated delivery date.

3. Courier service information - ID number and name of the courier service, used for the shipment.

4. Sender section - contains information about the sender of the shipment: The sender's phone number is masked to be compliant with GDPR; Sender name might also require masking for GDPR; Sender contact name (the person who is sending the shipment - mandatory if the sender is a company); Sender address in two lines.



Recipient section - contains information about the recipient of the shipment: The recipient's phone number is masked to be compliant with GDPR; Recipient name might also require masking for GDPR; Recipient contact name (the person who will receive the shipment - mandatory if the recipient is a company); Recipient address in three lines.


